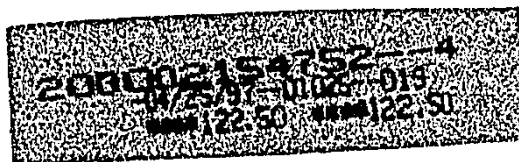

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE**

The name of the corporation is DESIGN CONCRETE CORPORATION.

**ARTICLE TWO**

The term of existence of the corporation is perpetual.

**ARTICLE THREE**

The purpose for which the corporation is organized is:

To engage in any activity or business permitted to a corporation under the laws of the United States and of the State of Florida.

**ARTICLE FOUR**

The aggregate number of shares which the corporation has authority to issue is ONE HUNDRED, all of which shall be common shares with a par value of ONE (\$1.00) DOLLAR per share.


