### **ARTICLE I - NAME - LOCATION**

The name of this corporation is M. E. P. MUNICIPAL INSPECTIONS, INC. at 10257 Breezeway Place, Boca Raton, Florida 33428.

# **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these articles.
