ARTICLES OF INCORPORATION
OF
CREATIVE SOURCING INTERNATIONAL, INC.

I, the undersigned, do hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Creative Sourcing International, Inc.

ARTICLE II

This corporation shall have perpetual existence, commencing on the subscription and acknowledgement of these Articles, except that in the event the Articles are not filed with the Secretary of State within five (5) days, exclusive of legal holidays, after subscription and acknowledgement hereof, corporate existence shall begin on the date that these Articles are filed with the Secretary of State.

ARTICLE III

The general purpose or purposes for which this corporation is being formed are to include the transaction of any or all lawful business permitted under the laws of the State of Florida.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is SEVEN THOUSAND FIVE HUNDRED (7,500) common shares of the par value of ONE DOLLAR (\$1) each.

ARTICLE V

The shareholders are hereby granted preemptive rights. Each shareholder, upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others, which price may be in excess of par.

ARTICLES VI

The registered agent and the street address of the initial registered office of the corporation in the State of Florida shall be: 80 SW 8th Street, Suite #2180, Miami, Florida 33130 and the name of the initial registered agent at such address is: Larry Shapiro

ARTICLE VII

The number of directors constituting the initial board of directors is TWO (2) and the name and address of each person who is to serve as a member thereof shall be:

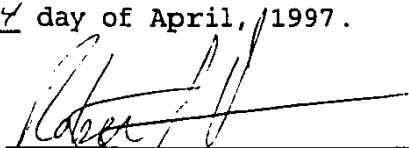

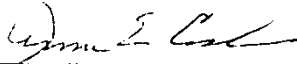

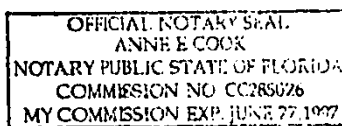
