**ARTICLE I - NAME**

The name of this corporation is Naturally Wise, Incorporated.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of retail sales.

**ARTICLE IV - CAPITAL STOCK**
