ARTICLE I-NAME

The name of this corporation is FEEL GOOD NUTRITIONAL COMPANY.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation shall have the power to engage in any lawful activity for which corporations may be organized for under the laws of the State of Florida.


