The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Acts hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Serbian Satellite Television International, Inc.

ARTICLE II PRINCIPAL OFFICE
