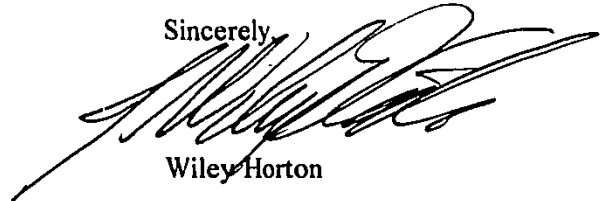

In compliance with the requirements of F.S. Chapters 607 and 621, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a professional service corporation.

ARTICLE I

The name of the corporation ("Corporation") is **JORDAN and PURVIS, P.A.**

ARTICLE II

The existence of the corporation shall begin on April 1, 1997.

ARTICLE III

The street address of the principal office of the Corporation is 1455 W. Washington St., Monticello, Florida 32344.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is four hundred (400), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

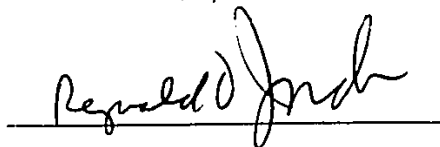
ARTICLE VIII

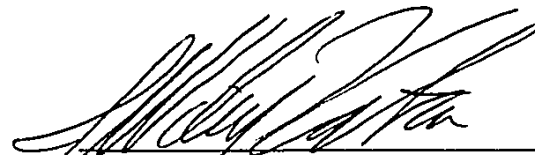
