

#### ARTICLES OF INCORPORATION OF

#### **BONITA GRANDE INVESTMENTS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### Article 1. Name and Address

The name of the Corporation is Bonita Grande Investments, Inc. The principal office, if known, or the mailing address of the Corporation is 3461 Bonita Bay Boulevard, Suite 210, Bonita Springs, Florida 33923.

Article 2. Duration

The duration of the Corporation is perpetual.

#### Article 3. Purpose

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

## Article 4. Shares

The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

### Article 5. Initial Registered Office and Agent
