ARTICLES OF INCORPORATION



OF

KT & T INTERNATIONAL, INC.

The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

KT & T INTERNATIONAL, INC.

The business of the corporation shall be carried on in Miami, Dade County Florida, and at such other place or places countries as may from time to time be authorized by the Board of Directors. Its principal office shall be 444 N.W. 28 Street, Miami, FL 33125.
