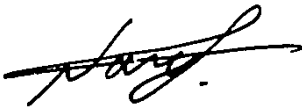

ARTICLE I - NAME

The name of the corporation is ----- 1966 FOODS, INC.

This corporation shall exist perpetually.

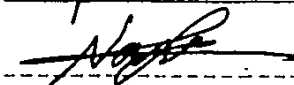

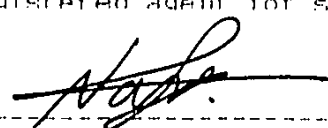

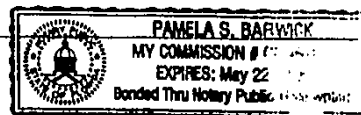
