**SECOND:** The document number of the corporation is P97000037968.

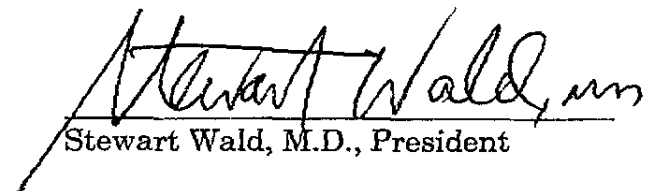
**THIRD:** The effective date of dissolution is December 31, 2005.
