ARTICLES OF INCORPORATION
OF
SATHYA SAI BABA VIDEOS DISTRIBUTION, INC.

The undersigned acting as subscribers of a Corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the Corporation is:

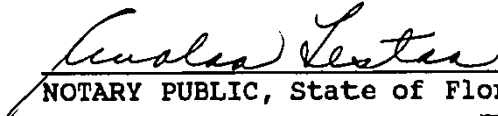

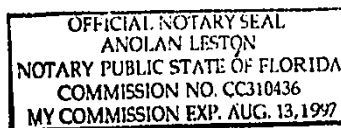
