- 6.1 The maximum number of shares that this Corporation is authoriBELLA MAINTENANCE SERVICES, INC.ed to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED (7,500)** shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).

- 6.3 The board of directors of the Corporation may authoriBELLA MAINTENANCE SERVICES, INC.e the issuance from time to time of shares of its stock of any class, whether now or hereafter authoriBELLA MAINTENANCE SERVICES, INC.ed, or securities convertible into shares of its stock of any class, whether now or hereafter authoriBELLA MAINTENANCE SERVICES, INC.ed, for such consideration as the board of directors may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in the bylaws of the Corporation.
