**ARTICLE I-Name**

The name of this corporation is Cross-Futch Development, Incorporated.

**ARTICLE II- Principal Office**

**ARTICLE III-Duration**

The existence of the corporation shall begin on April 28, 1997.  
This corporation shall have perpetual existence.

**ARTICLE IV-Purpose**

ARTICLE XI-Amendment

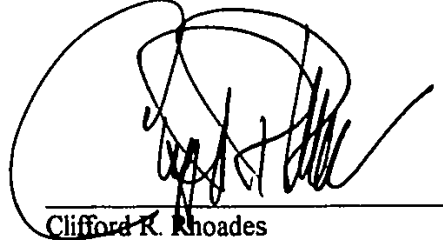

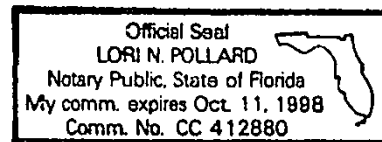

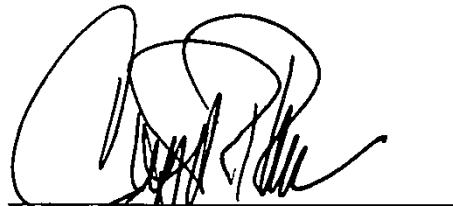
