The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following articles of incorporation for such corporation:

**ARTICLE I.**

The name of the corporation is W C PUBLICATIONS, INC.

**ARTICLE II.**

The duration of the corporation is perpetual.

**ARTICLE III.**

The purpose for which this corporation is organized is to engage in the business publishing, printing and distributing articles, papers, magazines, books or documents, including, but not limited to community directories, city directories, regional directories, national directories, government directories and any other lawful directory, paper, magazine, book, document, or article which may be lawfully published and distributed, and, also, the sale, solicitation, publishing and distribution of public or private promotional material,

advertisements or announcements, and to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

**ARTICLE IV.**

The aggregate number of shares which the corporation shall have the authority to issue shall be one hundred thousand shares of common stock at \$0.01 par value.
