## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WASTE INTEGRATION SERVICE CENTER, INC.

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of WASTE INTEGRATION SERVICE CENTER, INC., a Florida corporation (the "Corporation"), are hereby amended as follows:

- 1. The name of the Corporation is WASTE INTEGRATION SERVICE CENTER.
  - 2. The document number is P97000038258.
  - 3. Article I of the Articles of Incorporation is hereby amended to read as follows:

## "<u>Article I</u> Name
