

Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME and PRINCIPAL ADDRESS

The name of the corporation is: **JESSRICA CORPORATION** and the initial principal address of the corporation is: 800 14th Street, Key West, Florida 33040.

ARTICLE II
DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III
PURPOSE

The purpose for which the corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes as now exists or may hereafter be.

ARTICLE IV
CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock, par value \$10.00 per share.

ARTICLE V
REGISTERED AGENT

This corporation reserves the right to amend or repeal in the manner provided by law any provision(s) contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE IX
AGREEMENTS

The stockholder of this Corporation may enter into such stockholder and trustee agreements as they may see fit wherein such stockholder may limit his voting rights by virtue of such stockholder and trustee agreements.

ARTICLE X
SUB CHAPTER ELECTION

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock shall be issued and transferable only to natural persons who are not nonresident aliens.


