**ARTICLE I - NAME**


#### ARTICLE VII - REGISTERED AGENT

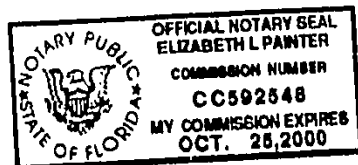
