ARTICLE I - Name

The name and address of the Corporation is:

This Corporation shall commence existence on the date of execution and acknowledgment of these articles.

ARTICLE III - Purpose

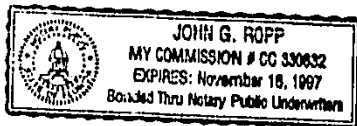

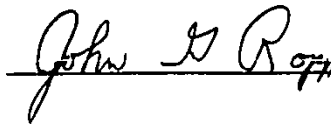

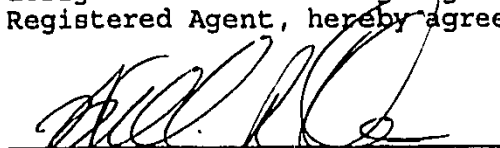
