ARTICLES OF INCORPORATION  
OF

ARTICLE I: CORPORATE NAME

The name of this corporation is Post Time Sports Bar & Grill,  
Inc.

ARTICLE II: PLACE OF BUSINESS

ARTICLE III: DURATION

The duration of this corporation shall be perpetual.  
Corporate existence shall commence at the time of filing the  
Articles of Incorporation with the Department of State.

ARTICLE IV: PURPOSE

This corporation is organized for the purpose of transacting

ARTICLE V: CAPITAL STOCK

A. Number:

The corporation shall have the authority to issue 1000 shares of capital stock with a par value of .01 per share.

B. Initial Issue:

1000 shares of capital stock shall be issued initially at the par value of .01 per share.

C. Classes of Stock:

The shares of stock of the corporation shall not be divided into classes.

D. Stated Capital:

The sum of the par value of all the shares of capital stock of the corporation that have been issued shall be stated capital of the corporation at any particular time.

ARTICLE VI: PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro rata share at the price at which it is offered to others.
