FRANKLIN S. AVERY, SR; FRANKLIN E. AVERY, JR; JOHN W. AVERY; and RANDY A. AVERY; being all of the incorporators of an existing Florida Corporation filed with the Secretary of State on April 29, 1997, as Document Number P97 0000 38 581; no shares of stock of any class or kind having been issued and no directors ever having been elected or appointed, do hereby adopt the following Amendments to the Articles of Incorporation of AVERY'S ELECTRIC, INC. pursuant to 607.1005 F.S.:

## ARTICLE\_III - SHARES

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

## ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of the same kind, class or series as that which he or she already holds, anytime after the effective date of this Amendment, with or without consideration, including but not limited to new stock issued as compensation to directors, officers, agents or employees of the corporation or to satisfy conversion or option rights; shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the same price at which it is offered to others.
