ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF UNIVERSITY CHEVROLET, INC.

TO: Department of State Tallahassee, Florida

ON AND STATE OF SE Pursuant to Florida law, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation. The name of the Corporation is UNIVERSITY CHEVROLET, INC. The following amendment of the Articles of Incorporation was adopted by the directors and shareholders of the Corporation on February 22, 2000, in the manner prescribed by Florida law:
