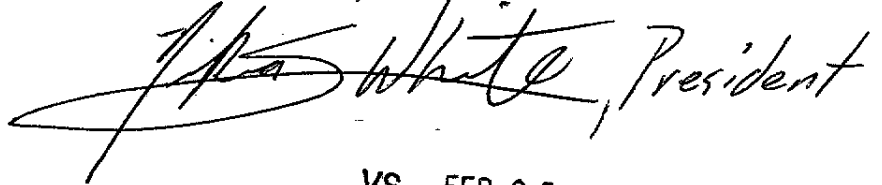

The undersigned, as the officer of the corporation authorized to execute this document, hereby certifies as follows:

At a special meeting of the Board of Directors and the shareholders of this corporation, called and held according to the applicable provisions of this corporation's bylaws, on January 5, 1998 at which meeting all of the member of the Board of Directors and all of the stockholders of record holding a majority of the issued and outstanding stock in this corporation were present, and the following resolution was unanimously adopted:

It is hereby resolved, by the Board of Directors and the shareholders of Drive of Jacksonville, Inc., that the said Board of Directors and shareholders deem it advisable, and hereby declare it to be advisable that the Article of Drive of Jacksonville, Inc. be amended to change the corporation name to The AIKIN Group, Inc. and that Nikia Shanard White shall serve as the initial Board of Director as President and General Partner. It is also amended that Nikia S. White shall have the power to dissolve, absolve and rename Board members and shall have the exclusive right to trademark "NIKIA SHANARD". NIKIA SHANARD is a division of Drive of Jacksonville, Inc. It is also amended that the number of directors shall never be less than ONE.
