#### ARTICLES OF INCORPORATION

#### OF

The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

# **ARTICLE 1**

The name of the corporation is Alexsys Computer Enterprises, Inc.

# **ARTICLE II**

The period of duration of the corporation is perpetual.

## ARTICLE III

The purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and Florida, including but limited to the wholesale and retail of personal computers.
