THE UNDERSIGNED, being competent to contract and desirous of forming a For-Profit Corporation under the applicable laws of the State of Florida, submit the following as its Articles of Incorporation.

**ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this Corporation shall be SIDELINE SPORTS GIFT SHOP, INC. The principal place of business for the Corporation shall be: 21485 Northwest 27<sup>th</sup> Avenue, Opa Locka, Florida 33056-1162.

**ARTICLE II - PURPOSE**

The primary purpose of this Corporation shall be to engage in retailing various souvenirs to organizations, businesses, governmental entities, and other interested individuals, and to conduct any other business deemed legal and lawful in this State and these United States.

**ARTICLE III - OUTSTANDING SHARES**

This Corporation shall have perpetual existence unless dissolved sooner by operation of law or by resolution of the shareholders.

**ARTICLE IV - OUTSTANDING SHARES**

The maximum number of shares which this Corporation shall have outstanding at any time shall be ONE THOUSAND (1,000) SHARES of Common Stock, each having a par value of ONE DOLLAR (\$1.00).

**ARTICLE V - INITIAL SUBSCRIBER AND MEMBERSHIP**

The initial subscriber of these Articles shall be Richard Lieber, 21485 Northwest 27<sup>th</sup> Avenue, Opa Locka, Florida 33056-1162. Membership in this Corporation shall be restricted to the Subscriber to these Articles and any other persons who

may be elected to membership, from time to time, at a regular meeting of the Corporation.

#### **ARTICLE VI - OFFICERS**

The affairs of this Corporation shall be managed by the officers. The officers of the Corporation shall be President, Treasurer, Secretary, and other offices which may be deemed necessary to carry out the business affairs of the Corporation. The following person shall serve as officer until a successor is duly elected at the annual meeting of the Corporation:
