ARTICLE 1- NAME

The name of this corporation is BROOKLYN COPIER & SUPPLY, INC.

ARTICLE 2- PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be: 6538 Coral Lake Drive, Margate, FL 33063

ARTICLE 3- PURPOSE
