ARTICLES OF INCORPORATION

RYMARK, INC.

The undersigned subscriber to these Articles of Incorporation, a natural tate of Florida.

1. The name of this corporation is: Rymark. Inc.

2. The post office address of the principal office of this Corporation. person competent to contract, hereby forms a corporation under the laws of the State of Florida.

The Board of Directors may from time to time move the office to any other place in Florida.

- 3. This Corporation shall have perpetual existence.
- 4. The Corporate purpose is to include the transaction of any and all lawful business of which corporations may be incorporated under the Florida General Corporation Act.
- 5. The number of shares that may be issued by the Corporation is 100 shares of common stock of the Par Value of five dollars a share.
