ARTICLES OF INCORPORATION

OF

KREIDER FAMILY FARMS, INC.

The undersigned incorporator has executed these Articles of Incorporation to establish a corporation (the "Corporation") under the Florida Business Corporation Act (Chapter 607, Florida Statutes).

1. Name. The name of the Corporation is:

- 4. <u>Authorized Shares</u>. The Corporation is authorized to issue 100,000 shares of common stock having a par value of \$0.01 per share.
