ARTICLES OF INCORPORATION

OF

The undersigned, acting as sole Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME AND CORPORATION'S PRINCIPAL OFFICE AND MAIN ADDRESS

ARTICLE II. COMMENCEMENT AND DURATION

The corporation shall commence existence on January 1, 1996, or on the date these articles are filed with the Secretary of State if such date is later than January 1, 1996. The period of its duration is perpetual.

ARTICLE III. PURPOSE

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue Five Thousand (5,000) shares, all of one class, at \$1.00 par value, with Two Hundred (200) shares to be issued to initial director Donna Schulke


ARTICLE VIII. AMENDMENT OF ARTICLES
