**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I**

**NAME AND ADDRESS**

1. The name of this corporation is AJL Carpet Care, Inc. and the address of the corporation is 12204-5 Sag Harbor Ct., Wellington, Florida 33414.

**ARTICLE II**

**DURATION**

2. The duration of this corporation shall be perpetual.

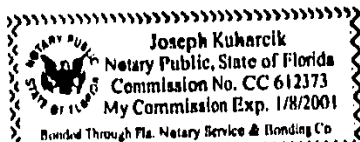


