#### ARTICLES OF INCORPORATION

OF

#### SELIGMAN FAMILY INVESTMENTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I NAME

The name of the corporation shall be:

## ARTICLE II PRINCIPAL OFFICE

The mailing address of the initial principal office of this corporation is Broken Sound Clubside Point, 2441 N.W. 59th Street, #503, Boca Raton, Florida 33496. The Board of Directors may, from time to time, change the street and post office address of the principal office of the corporation.

#### ARTICLE III PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE IV CAPITAL STOCK
