ARTICLES OF INCORPORATION OF LE BRASSERIE, INC.

SEAMONE PORIORIOS Pursuant to the Florida Business Corporation Act, the undersigned incorporator of Le Brasserie, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND ADDRESS

The name of the Corporation is Le Brasserie, Inc. The Corporation's principal office and mailing address is 1721 West Fletcher Avenue, P.O. Box 2065, Tampa, Florida 33601.

ARTICLE II **BUSINESS AND ACTIVITIES**
