The undersigned incorporators, each of whom is licensed or otherwise legally authorized to practice the profession of law or perform logal services in the State of Florida, associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles of incorporation for the corporation:

ARTICLE I - NAME
