## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF LAND DESIGN SOUTH OF FLORIDA, INC.

Pursuant to the provisions of the Florida General Corporation Act, the undersigned for profit Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Land Design South of Florida, Inc.
- 2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the Corporation on the 23 day of PECINTER 2005, in the manner prescribed by the Florida General Corporation Act:

Article IV of the Articles of Incorporation of Land Design South of Florida, Inc., which were filed on May 1, 1997, is hereby deleted in its entirety and is amended to read as follows:
