ARTICLES OF INCORPORATION

ARTICLE I- NAME: The name of this corporation is NATIONS FINANCIAL SERVICES INC.

ARTICLE II- DURATION: This corporation shall have perpetual existence commencing on the 5th day of May, 1997.

ARTICLE III-PURPOSE: This corporation is organized for the purpose of operating Pawn Shops and for the conduct of any and all lawful business, and this corporation shall have all powers to effect its purpose.
