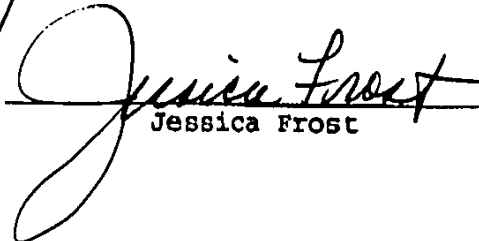

DISSOLUTION

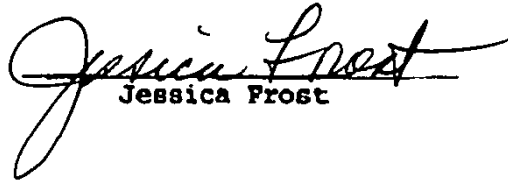
