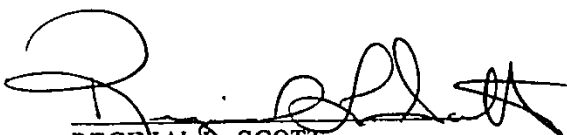

ARTICLE VI

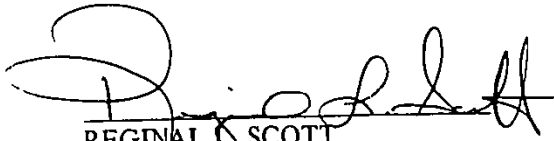

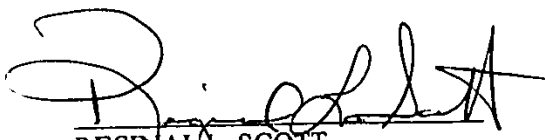

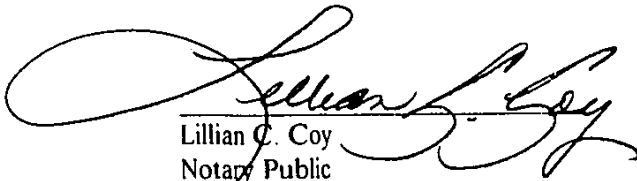
