ARTICLE I - NAME

The name of this corporation shall be THE KUMMER-SCHOBERER CORPORATION.

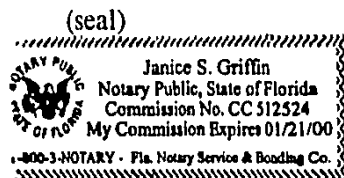

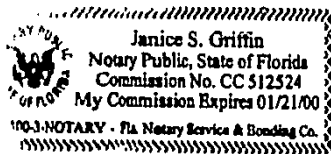

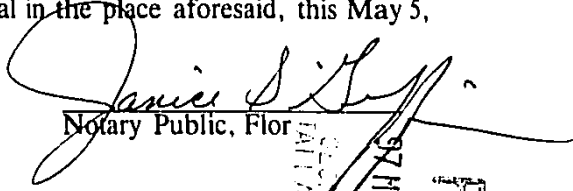
