ARTICLE VX - AMENDMENT

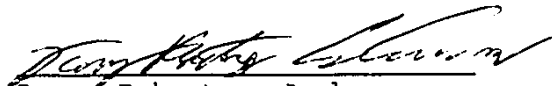

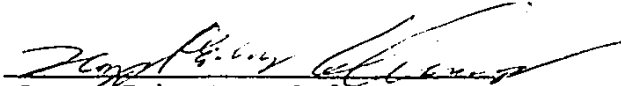
