### ARTICLES OF INCORPORATION OF CANAL, INC.

The undersigned incorporators, for the purpose of forming a corporation under the local florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation shall be CANAL, INC.

#### ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be **8401 Crespi Boulevard, Miami Beach, Florida 33141.** Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

#### ARTICLE III. PURPOSE

The general nature of the business to be transacted by the corporation shall include any or all lawful business with all powers conferred upon Corporations by the Laws of the State of Florida.
