# **ARTICLE 1 - NAME**

The name of the corporation is:

Aura Technologies, Inc.

### **ARTICLE II - DURATION**

The date when the Corporation's existence shall begin will be the date of subscription and acknowledge stated herein if this Certificate of Incorporation of Articles of Incorporation are filed within five (5) days, exclusive of legal holidays, after subscription and acknowledgment hereof, and are subsequently approved by the Secretary of State, and all filing fees and taxes paid; otherwise, it shall be the date when the Articles of Incorporation are filed in the Office of the Secretary of State and approved.

# ARTICLE III - PURPOSE
