It has just come to my attention that SUE CORPORATION was administratively dissolved on October 16, 1998, "for failure to file its annual report".

In researching this development, I find that our corporate documents were filed with the wrong suite number and zip code. Our postman is not familiar with the SUE CORPORATION name and would not have known to forward it to Suite 550. I have learned that we did not receive "Notice of Annual Report"; that the first two notices were "returned" to your office. The third was possibly lost since your records show not returned, and yet, we never received it. We are now aware of our responsibility to request the Notice if not received and, subsequently, to file it with your offices.

Per my conversation with Trevor this morning, it is my understanding that since we never received the Notices, and this letter of explanation is sent, the \$600 "reinstatement fee" is waived. Therefore, I am enclosing a company check in the amount of \$308.75 to cover the annual fees for '98 and '99, as well as, one certified copy of the Certificate of Status.

Thank you for your assistance and anticipated, expedited action in this matter.
