The undersigned, for the purpose of forming a for-profit corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

**ARTICLE ONE  
NAME**

The name of the Corporation is Dezj-Pol, Inc.

**ARTICLE TWO  
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE THREE  
PURPOSE**

The primary purpose for which the Corporation is formed is to engage in the business of operating equestrian event facilities and may, in addition, engage in any lawful business for which corporations can be formed.

**ARTICLE FOUR  
CAPITAL STOCK**

The aggregate number of shares which the Corporation has authority to issue is One Thousand (1,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share.

**ARTICLE FIVE  
PRINCIPAL OFFICE**



The Corporation shall be deemed to commence its existence at the time these Articles are filed.


