I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida.

I.

The name of the corporation is P.A. DAWSON ENTERPRISES, INC., whose principal office is located at 4050 S. US Highway One, Suite #303, Jupiter, Palm Beach County, Florida 33477.

II.

The period of duration of the corporation is perpetual unless dissolved according to Florida law.

III.

The purpose for which the corporation is organized is to engage in interior design or any other business or any other act or activities for which corporations may be organized under the General Statutes of the State of Florida.

IV.

The corporation shall have the authority to issue 10,000 (ten thousand) shares of common stock with a par value of \$1.00 (one dollar).


