## ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **SCHLEMAN & LITTLE ENTERPRISES**, **INC**. The principle place of business of this corporation shall be: 751 25th Ave. N., St. Petersburg, FL 33704-3313.

#### ARTICLE TWO - NATURE OF BUSINESS
