The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: SOUTH FLORIDA SOCCER SCHOOL, INC.

ARTICLE II - NATURE OF BUSINESS
