ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a, FLORIDA corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be CAPTIVA RENDEZVOUS, INC.

ARTICLE II PRINCIPAL OFFICE
