ARTICLES OF INCORPORATION

We, the undersigned persons of the age of more than eighteen (18) years of age, all of whom are residents of the State of Florida and citizens of the United States, do hereby associate ourselves together for the purpose of forming a corporation for profit under the statutes of the - COTIVE DATE 4-30-97 State of Florida.

<u>ARTICLE I</u>

The name of the corporation is: U.S.A. SOUTH VOLLEYCENTER, INC.

ARTICLE II

The corporation shall have perpetual existence and its existence shall commence on the date of execution and acknowledgment of these articles as it appears on the signature page.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business permitted by the Florida General Corporation Act and shall have all the powers granted under act to carry out its purposes, including the following:

- e).
