# *Articles of Incorporation*

## *Nguyen's Floral, Incorporated*

The undersigned, being a natural person, does hereby act as incorporator in adopting the following articles of incorporation for the purpose of organizing a profit corporation pursuant to the provisions of the State of Florida Stock Corporation Act:

### ARTICLE ONE

The name of the corporation shall be:

**Nguyen's Floral, Incorporated**

### ARTICLE TWO

The term for which this corporation shall exist shall be perpetual.

### ARTICLE THREE

The general nature of the business to be transacted by the corporation and the purpose for which it is formed are to be as follows:

- (a) Retail sales in the State of Florida pursuant to the laws of Florida and the U.S.A.
- (b) To do any activity as corporation organized under chapter 607 of the Florida Statutes may now or hereafter lawfully do, to do, and for the accomplishment of any of the purposes or the attaining of any of the objects enumerated in these Articles of Incorporation, or any of the amendments hereof, either as principal or agent, and either alone or in connection with other firms, corporations or individuals, all and every thing necessary, suitable, convenient, or proper for, or in connection

with, or incident to, accomplishment of any of the purposes or the attainment of any one or more objects herein enumerated, or designed directly or indirectly to promote the interest of this corporation or to enhance in and carry on any and every lawful activity in any manner whatsoever not prohibited by law, whether or not the same to be necessary or incident to the attainment of the objects of this corporation, or whether or not such activity is similar in nature to the objects set forth in these Articles of Incorporation or any and all powers, rights, and privileges which a corporation may now or exercise under Chapter 607 of the Florida Statutes, or under any act amendatory thereto, supplemental thereto, or substituted therefor.

- (c) The foregoing paragraph shall be construed as enumerating the purposes, objects, and powers of this corporation and to recitation, expression or declaration of specific powers or purposes herein enumerated shall be deemed to be exclusive, but it is hereby expressed and declared that all other lawful powers not inconsistent herewith are hereby included.

#### **ARTICLE FOUR**

The maximum amount of capital stock that the corporation is authorized to have outstanding shall be 1000 shares at a par value of \$0.01 per share, each share of which shall entitle the owner thereof to one vote at any meeting of the stockholders. The whole or any part of the capital stock of this corporation shall be payable as lawful money of the United States of America, or property, at a just valuation to be fixed by the stockholders.

#### **ARTICLE FIVE**

The sale of common stock of the corporation shall be restricted except by mutual agreement of all stockholders.

#### **ARTICLE SIX**

In the event of issuance or sale of corporate shares, the existing stockholders shall have preemptive rights thereto.

## ARTICLE SEVEN

The business of the corporation shall be managed by its officers, who shall be elected annually by the stockholders of the corporation. The initial officers of the corporation shall be as follows:




