ARTICLE I - NAME

The name of the corporation shall be PRECISION PAVERS TRI-COUNTY, INC. The mailing address for the corporation is 2121 Tallevast Road, Sarasota, Florida, 34243.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
